AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2, SERIES OF 2020 FOR FISCAL YEAR 2020 OF THE MUNICIPAL GOVERNMENT OF MONCADA, IN THE TOTAL AMOUNT OF SIX MILLION FOUR HUNDRED FOURTEEN THOUSAND PESOS (PHP 6,414,000.00)

WHEREAS, this August Body is in receipt of the proposed Supplemental Budget No. 2 for FY 2020, to provide appropriation for the purchase of Lot for Cemetery 3 site at Brgy. Camposanto 1-Norte, Moncada, Tarlac;
