MUNICIPAL ORDINANCE NO. 12

Series of 2020

AN ORDINANCE DESIGNATING LOADING AND UNLOADING ZONES FOR PUBLIC UTILITY VEHICLES OPERATED BY TAMOGEPA TRANSPORT COOPERATIVE AND PROVIDING PENALTIES FOR VIOLATORS THEREOF

WHEREAS, pertinent laws, issuances and provisions of the Local Government Code state that every local government unit shall provide its residents adequate transportation facilities which include the orderly flow of transportation along its roads and highways;

WHEREAS, the Sangguniang Bayan is conferred with the power and authority to establish loading and unloading zones, bus stops and vehicle terminals to be occupied by public vehicles when not in use;

WHEREAS, to ensure the widest implementation of road clearing operations and address the lingering problems of illegal parking and improper loading and unloading of passengers on-board Public Utility Vehicles (PUVs), there is an urgent need to strictly enforce the use of loading and unloading zones for these conveyances plying the route in Moncada;

NOW, THEREFORE, on motion by Coun. Celeste A. Ayson, duly seconded:

Be it ENACTED by the Sangguniang Bayan of Moncada in session assembled, that:

SECTION 1. Loading and Unloading Zones. – Public Utility Vehicles operated by TAMOGÉPA Transport Cooperative are only allowed to load and unload passengers within the Economic Zone in the following areas:

- A. LOADING AREAS: (Going to Tarlac City)
 - a.1 TAMOGÉPA Terminal (Modern Jeepneys) – Brgy. Camposanto 1 Norte
 - a.2 PICK-UP AREA – In front of Kingship Hardware – Brgy. Poblacion 2

- B. UNLOADING AREAS: (Coming from Tarlac City)
 - b.1 Shell Gasoline Station – Brgy. Poblacion 1
 - b.2 Bus Stop - In front of Limpingco Palay Trading and 24/7 Pandesalan – Brgy. Poblacion 1

Economic Zone as used in this Ordinance refers to the central hub of economic activities of the town with a one (1) kilometer radius from the public market up to Winfair Supermarket in the north and Kingship Hardware in the south;

Provided, that PUVs operated by TAMOGÉPA Transport Cooperative shall only load passengers at their designated terminal located within the economic zone to avoid congestion in the designated south-bound bus stop. However, TAMOGÉPA PUVs may pick-up passengers beyond the economic zone going south in front of Kingship Hardware located at Brgy. Poblacion 2 for the convenience of the riding public.

SEC 2. Penalties for Illegal Loading and Unloading of Passengers. – Operators found in violation of this Ordinance shall be meted the following fines and penalties:

- a. First Offense – P 150.00
- b. Second Offense – P300.00
- c. Third Offense – P 1,000.00 and suspension of operator of PUV for 60 days

An Ordinance Violation Receipt (OVR) or Traffic Violation Ticket (TVT), as the case may be, shall be issued to persons or entities violating this Ordinance. Fines incurred by the violator shall be settled at the Municipal Treasurer's Office.

SEC 3. Implementing Office. The Philippine National Police and local traffic enforcers deputized by the LGU shall implement the provisions of this Ordinance.

SEC 4. Separability Clause. – If for any reason, any section of this Ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.

SEC 5. Repealing Clause. – All ordinances, rules and regulations or parts thereof in conflict with this Ordinance are hereby repealed or modified accordingly.


SEC 6. Effectivity Clause. – This Ordinance shall take effect fifteen (15) days following its posting in at least three conspicuous places in the municipality and likewise in the official social media platforms and website of the LGU of Moncada.
