RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PANIQUI DIALYSIS CENTER, PANIQUI, TARLAC TO CATER HEMODIALYSIS SERVICES FOR INDIGENT PATIENTS FROM MONCADA

WHEREAS, the Paniqui Dialysis Center expressed its willingness to cater to the health needs of Moncadenians as endorsed by the Municipal Government of Moncada subject to the terms and conditions stipulated in the MOA;
