(RCHI), a non-government registered and licensed Residential and Community-Based Social Welfare and Development Agency, operates to help disadvantaged children and youth and their families to cope with poverty and perennial social problems that gravely affect their way of life;

**WHEREAS**, said agency adopts a social work approach in order to provide proper and temporary care to disadvantaged children and capacitate them in various areas such as education, social, cultural, home life, practical skills and spiritual aspect to become productive and responsible citizens of the community;

**WHEREAS**, the partnership between RCHI and Moncada LGU aims to deliver a wholesome program for the disadvantaged children and youth from Moncada through a residential care for the abandoned, neglected, orphaned children who are in need of special support;
