**RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH GRACIA TELECOMMUNICATIONS CORPORATION FOR THE ADOPTION OF ELECTRONIC PAYMENT COLLECTION SERVICES IN THE MUNICIPALITY OF MONCADA**

**WHEREAS**, the Municipal Government of Moncada, in compliance with RA 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 aims to establish effective practices and efficient turnaround of the delivery of government services through a business one-stop-shop for business and license permit application and renewal, tax payments, as well as to provide easy and accessible payment options for its constituents to avail of government services;

**WHEREAS**, in view of Department of Trade and Industry (DTI) and Department of Finance (DOF) Joint Administrative Order No. 2, the LGU intends to bring about more efficient and effective payment and collection services for the transacting public through an electronic payment and collection system which allows government to better manage its financial resources thereby improving its revenue generating capability;

**WHEREAS**, the LGU intends to outsource the services of Gracia Telecommunications Corporation which offers electronic payment collection

services and payment facilities that can be integrated to the LGU's Biller System at no cost to the municipality;

Aquino, to enter into a Memorandum of Agreement with Gracia Telecommunications Corporation for the adoption of electronic payment collection services in the Municipality of Moncada;
