RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO TO RENEW THE DISPOSAL AGREEMENT WITH METRO CLARK WASTE MANAGEMENT CORPORATION FOR JULY 1, 2022 UNTIL DECEMBER 31, 2022

EN BANC

WHEREAS, the Metro Clark Waste Management Corporation (MCWM) owns and operates an Engineered Sanitary Landfill located at Clark Special Economic Zone, Sitio Kalangitan, Brgy. Cut Cut II, Capas, Tarlac, built and operated in accordance with Republic Act 9003, otherwise known as the Ecological Solid Waste Management Act of 2000;

WHEREAS, the Municipality of Moncada generates tons of residual wastes which are transported and disposed at the aforesaid landfill through an existing disposal agreement with Metro Clark Waste Management Corporation;

WHEREAS, the present Disposal Agreement is valid only until June 30, 2022, and thus, the LGU of Moncada intends to renew the said agreement for July 1, 2022 to December 31, 2022 to comply with the provisions of Republic Act 9003 and support the locality's zero waste management program;

WHEREAS, after a careful review of the agreement, this August Body favorably endorses the same for renewal;
