**RESOLUTION EXTENDING THE PAYMENT OF BUSINESS TAXES AND OTHER RECURRING REGULATORY FEES IMPOSED BY THE MUNICIPAL GOVERNMENT OF MONCADA AND WAIVING ALL PENALTIES AND SURCHARGES THEREOF EFFECTIVE JANUARY 21 TO FEBRUARY 28, 2022**

**WHEREAS**, following another wave of COVID-19 surge in the country brought by the emergence of Omicron variant, the government has put in place stringent preventive and proactive measures to mitigate the effects of health crisis by imposing Alert Level System in the country;

**WHEREAS**, the imposition of measures under Alert Level 3 caused restriction in the mobility among people thereby causing disruption in the economic activities all over the country and affected the means of livelihood and subsistence of low-income households;

**WHEREAS**, it is therefore imperative to move the statutory deadlines and timelines for the payment of local business taxes, fees, and other charges required by law, and the grant of any benefit, in order to ease the burden on individuals and business owners alike;

**WHEREAS**, Section 167 of the Republic Act 7160 or the Local Government Code provides that the Sangguniang Bayan may, for justifiable reason or cause as mentioned in the foregoing premises, extend the time of payment of taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months;
