RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE GRANT OF LOTTO/SMALL TOWN LOTTERY FUND SHARE AND CALAMITY ASSISTANCE

WHEREAS, presented for consideration by this Body is a Memorandum of Agreement between the Municipal Government of Moncada, Tarlac and the Philippine Charity Sweepstakes Office (PCSO) for the operation of Small-Town Lottery (STL);

WHEREAS, the PCSO, under the Office of the President, is the principal government agency for raising and providing funds for health programs, medical assistance and services and charities of national character through conduct of sweepstakes races, lotteries and other similar activities;

WHEREAS, in pursuit of its mandate, the PCSO is committed to raise revenues for the government through the operation of Lotto and Small-Town Lottery (STL) and provide LGUs a portion of the charity fund generated from the sales thereof within their jurisdiction, to be used for medical, calamity and health-related services;

WHEREAS, the Local Government Unit of Moncada is committed to giving its full support and cooperation in PCSO's Lotto and STL operations and all PCSO-initiated programs, projects and gaming activities;
