RESOLUTION ADOPTING THE 2022 REVISED CITIZENS' CHARTER OF THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC AS A MECHANISM FOR IMPROVING EFFICIENCY OF DELIVERING GOVERNMENT FRONTLINE SERVICES

WHEREAS, an existing Moncada LGU Citizens' Charter, which was crafted and adopted on December 1, 2020 aims to promote transparency in local governance;

WHEREAS, said document is a guide in fostering good governance through efficient and effective delivery of frontline services;

WHEREAS, a new updated Citizens' Charter for 2022, however, has been prepared for adoption by the concerned offices of the Local Government Unit of Moncada for the same purpose;

NOW, THEREFORE, on motion by Coun. Thelmaflor A. Espejo, duly seconded by Coun. Janius M. Yasay;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Education and Human Resource Development and Committee on Rules, Legal Matters, Justice and Good Governance, hereby adopts the 2022 Revised Citizens' Charter of the Municipal Government of Moncada as a mechanism for improving efficiency of delivering government frontline services;
