RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE OFFICE OF THE PRESIDENT FOR THE RELEASE OF ASSISTANCE FOR COVID-19 RESPONSE CHARGED TO SOCIO-CIVIC PROJECTS FUND OF THE NATIONAL GOVERNMENT

WHEREAS, the Honorable Mayor Estelita M. Aquino is requesting for authority to enter into a Memorandum of Agreement with the Office of the President represented by Executive Secretary Salvador C. Medialdea for the release of assistance to the LGU to cater and address the immediate needs of the people affected by COVID-19 health crisis;

WHEREAS, Section 17 (f) of RA 7160 (Local Government Code) states that the national government or the next higher level of LGU may provide or augment the basic services and facilities assigned to a lower level of LGU when such services or facilities are not made available or, if made available, are inadequate to meet the requirements of its inhabitants;

WHEREAS, the Office of the President, through President Rodrigo R. Duterte, sees the need to provide financial assistance to the LGU of Moncada to augment its financial resources and provide Moncadenians basic necessities such as food and medicine, particularly the indigent and underprivileged citizens;

WHEREAS, after a careful review of the proposed MOA, the SB finds the same to be beneficial for the welfare of citizens grappling with the ill-effects of economic and health crisis brought by the COVID-19 pandemic;
