RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC, THROUGH THE HONORABLE MAYOR ESTELITA M. AGUINO OR MR. VON MARK D. CORPUZ, MUNICIPAL ACCOUNTANT, TO AMEND THE REGISTRATION OF THE LGU WITH THE BUREAU OF INTERNAL REVENUE – DISTRICT OFFICE NO. 17B PANIQUI, TARLAC TO INCORPORATE TAX ACTIVITIES INVOLVING THE MANAGEMENT OF ECONOMIC ENTERPRISES AND INCOME-GENERATING PROJECTS OF THE MUNICIPAL GOVERNMENT

WHEREAS, the Municipal Government of Moncada is required by law to register with the BIR, considering its proprietary function as an entity that manages its economic enterprises and other functions such as filing of withholding taxes for the income of its officials and employees and for other transactions entered into with private entities that involve payment of goods and services;

WHEREAS, the Municipal Government of Moncada was granted with a Tax Identification Number (TIN) and Certificate of Registration (COR) dated January 1, 1997 specified as 979-977-000;

WHEREAS, Section 22 (d) of RA 7160 (Local Government Code) states that local government units shall enjoy full autonomy in the exercise of their proprietary functions and in the management of their economic enterprises, subject to limitations provided in the Code and other applicable laws;

WHEREAS, Section 17(b)(2)(j) of the same Code states that LGUs may, by Ordinance, sell, lease, encumber, or otherwise dispose of public economic enterprises owned by them in their propriety capacity;

WHEREAS, considering the above premises, there is a need to make necessary amendments to the tax registration of the LGU to incorporate the imposition and levying of taxes on lease agreements between private enterprises and the LGU on properties which are part of the Income-Generating Projects (IGPs) of the Municipal Government;

NOW, THEREFORE, premises considered, and on motion by Coun. Celeste A. Ayson, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby authorizes the Municipal Government of Moncada, Tarlac, through the Honorable Mayor Estelita M. Aquino or Mr. Von Mark D. Corpuz, Municipal Accountant, to amend the registration of the LGU with the Bureau of Internal Revenue – District Office No. 17B to incorporate tax activities involving the management of economic enterprises and income-generating projects of the Municipal Government;

RESOLVED, FURTHER, that this Resolution be forwarded to the Bureau of Internal Revenue (BIR) RDO No. 17-B, thru the Revenue District Officer, for their information and appropriate action;
