WHEREAS, the Universal Healthcare Law (RA 11223) was enacted in a bid to ensure that all Filipinos are guaranteed equitable access to quality and affordable health care goods and services, and protected against financial risk;

WHEREAS, consistent with the above premise, the Municipal Government of Moncada seeks to expand its basic healthcare services in compliance with the guidelines set forth by the Department of Health for the operation of Primary Care Facilities (PCFs) that will provide a wider array of health services and facilities for the citizens of Moncada;

WHEREAS, the existing Rural Health Units are therefore developed and upgraded to become more responsive to the dynamic healthcare needs of our people who shall be afforded with inclusive, equitable and quality health services at all times;

WHEREAS, in compliance with the new requirements for the licensing of Primary care Facilities, there is an imperative need to certify and attest to the ownership of Rural Health Units which are part of the Municipal Government's infrastructure assets and facilities;

WHEREAS, the property in Brgy. Rizal where the RHU II is situated belongs to the Municipal Government of Moncada under Transfer Certificate of Title No.263678, Lot No. 4 with an aggregate land area of nine hundred twelve square meters (912 sq.m.) donated by Purification Nagtalon Quintos et.al. for the purpose of establishing a health center, day care center and Barangay Hall;

WHEREAS, construction of said RHU II in Brgy. Rizal of this municipality was completed last July 18, 2005 which materialized through the Annual Budget of Moncada LGU by virtue of Appropriation Ordinance No. 04, Series of 2004 providing for the funding for its construction, operation and personnel complement;

NOW, THEREFORE, premises considered, and on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health and Social Services, hereby certifies and affirms that the Municipal Government of Moncada is the rightful registered owner of a property at Barangay Rizal of this municipality where the Rural Health Unit II is situated covered by Transfer Certificate of Title No. 263678, Lot No. 4;

RESOLVED, FURTHER, that the Rural Health Unit II is also part of the Plant, Property and Equipment (PPE) duly owned by the Municipal Government of Moncada filed under Property Identification No. (PIN) 017-09-0023-008-(19)-1001 on its Tax Declaration of Real Property;

RESOLVED, FURTHER, that this Resolution be forwarded to the Department of Health – CLCHD, thru the Regulatory, Licensing and Enforcement Division (RLED) for their information and appropriate action;
