WHEREAS, the Sangguniang Barangays of Sta Lucia West, San Roque, Sta Lucia East, Maluac, and Mabini submitted their respective barangay ordinances entitled "An Ordinance Establishing Barangay VAWC Desk and a Recording and Reporting System;"

WHEREAS, said Ordinances aim to promote the declared policy of the State to address violence committed against women and children and protect their rights as guaranteed by the Constitution and all pertinent laws;
