RESOLUTION OPERATIONALIZING DILG MEMORANDUM DATED SEPTEMBER 14, 2022, REITERATING PERTINENT PROVISIONS ON ROAD SAFETY AND TRANSPORTATION

WHEREAS, this August Body is in receipt of a Memorandum from the Department of the Interior and Local Government (DILG) reiterating pertinent provisions on road safety and transportation;

WHEREAS, aforesaid Memorandum cited a certain provision of DILG-DOTC Joint Memorandum Circular (JMC) No. 01, Series of 2008 which states the following:

“3.4 On the Issuance of Traffic Citation Tickets

The LGUs can issue traffic citation tickets but only the LTO and their deputized agents can confiscate drivers’ licenses. xxx”

WHEREAS, under the Memorandum, all LGUs are directed to review their ordinances, orders and local issuances to ensure conformity and compliance with the said provision and with entirety of the above-cited JMC;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Transportation, hereby operationalizes DILG Memorandum dated September 14, 2022 reiterating pertinent provisions on road safety and transportation, to wit:

- 1) Only the LTO personnel and their deputized agents are allowed to confiscate drivers' licenses for traffic violations committed by individuals in the Municipality of Moncada;
- 2) Civic groups and force multipliers in partnership with the PNP may be allowed to issue Traffic Citation Tickets or Ordinance Violation Receipts to violators of road safety ordinances, however, they are **prohibited** from confiscating drivers' licenses.
- 3) The Philippine National Police – Moncada Police Station is requested to comply with the said memorandum and cause the immediate implementation thereof and this Resolution;

RESOLVED, FURTHER, that copies of this Resolution be furnished the Honorable Mayor Estelita M. Aquino, the Chief of Police, Moncada PNP, and all concerned offices and agencies for their information and appropriate action;
