**RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF TARLAC FOR THE GENERAL REVISION OF REAL PROPERTY ASSESSMENTS PROJECT**

**WHEREAS**, in line with the Provincial Tax Ordinance No. 2022-01, the conduct of General Revision of Real Property Assessments is necessary to equalize and update the valuation of real properties within the local government unit;

**WHEREAS**, the implementation of General Revision of Real Property Assessments shall be a joint endeavor between the Provincial Government of Tarlac and the Municipal Government of Moncada and both parties agreed to equally share in all the costs of the said project;

**WHEREAS**, the Municipal Government of Moncada allocates the necessary funding requirements for the project as approved in the Annual Budget the total amount of three hundred thirty thousand seven hundred fifteen pesos (P 330,715.00) as its counterpart to the project, subject to supplemental appropriations if so demanded;

**WHEREAS**, after a careful review of the subject MOA, the Committee on Finance, Ways and Means and Appropriations favorably endorse the same for the Body's approval and authorization;
