RESOLUTION ENDORSING AND NOMINATING MR. DEAN MICHAEL V. DUQUE, SON OF THE LATE VICE MAYOR JAIME O. DUQUE, TO FILL UP THE VACANCY AS A MEMBER OF THE SANGGUNIANG BAYAN OF MONCADA, TARLAC

WHEREAS, incumbent Vice Mayor Jaime O. Duque passed away on November 8, 2022, thereby creating a vacancy in the Office of the Vice Mayor which has been filled up by Coun. Ramon Benito M. Aquino, the highest-ranking Sanggunian member who succeeded as Vice Mayor on November 15, 2022 pursuant to Sec. 44 of the Local Government Code;

WHEREAS, Section 45 (b) of the same Code provides for the manner by which a vacancy in the membership in the Sangguniang Bayan shall be filled up. In which case, the nominee shall come from the same political party as that of the Sanggunian member who caused the last vacancy and shall serve the unexpired term of the vacant office;

WHEREAS, in compliance with the requisites provided by law, this August Body is endorsing and nominating Mr. Dean Michael V. Duque, son of the late Vice Mayor Jaime O. Duque, to assume the position vacated by then SB Member Ramon Benito M. Aquino to serve the unexpired term thereof;

WHEREAS, Mr. Duque has sworn in as a member of the Nationalist People's Coalition last November 17, 2022 before the Honorable Governor Susan A. Yap who is the party's incumbent Provincial Chairperson;
