RESOLUTION EARNESTLY REQUESTING THE OFFICE OF CIVIL DEFENSE, THROUGH UNDERSECRETARY RAYMUNDO B. FERRER, ADMINISTRATOR, FOR THE ALLOCATION OF FUNDS IN THE TOTAL AMOUNT OF FIFTY MILLION PESOS (PHP 50,000,000.00) FOR THE PROPOSED CONSTRUCTION OF SLOPE PROTECTION OF BANAANG RIVER (LEFT PORTION) AT BARANGAY BANAANG WEST, THIS MUNICIPALITY

WHEREAS, the Municipality of Moncada is among the few localities situated in flood-catchment areas in the province, it being traversed by waterways such as rivers and creeks;

WHEREAS, in order to protect the lower catchment areas from landslides, soil erosion and subsequent flooding, particularly the western barangays, one of the identified priority flood control projects is the proposed construction of slope protection of Banaoang River (Left Side) at Brgy. Banaoang West of this municipality;

WHEREAS, the LGU of Moncada, upon the recommendations of the Municipal Disaster Risk Reduction and Management Office (MDRRMO) and Municipal Engineering Office (MEO), has incorporated in its 2022 Annual Investment Program the above-cited project amounting to Fifty Million Pesos (Php 50,000,000.00);

WHEREAS, much to the desire of the local government to implement the said project, it would not be feasible as yet due to financial constraints to cover

the expenses therefor, hence, the need for funding assistance from the National Government;

NOW, THEREFORE, on joint motion by Coun. Constante Nestor A. Favis and Coun. Thelmaflor A. Espejo, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations and Committee on Public Works and Infrastructure, hereby earnestly requests the Office of Civil Defense, through Undersecretary Raymundo B. Ferrer, Administrator, for the allocation of funds in the total amount of Fifty Million Pesos (Php 50,000,000.00) for the proposed construction of slope protection of Banaoang River (Left Portion) at Brgy. Banaoang West of this municipality;

RESOLVED FURTHER, that this Resolution be forwarded to the Office of Civil Defense and all concerned parties for their favorable consideration;
