**RESOLUTION RECONSTITUTING THE MONCADA PEOPLE'S  
COUNCIL FOR LEGISLATIVE TERM 2022 - 2025**

**WHEREAS**, as provided for under Republic Act 7160, the local government shall encourage Civil Society Organizations (CSOs) and People's Organizations to participate in the formulation of plans, programs, projects and policies of the Local Government Unit;

**WHEREAS**, DILG Memorandum Circular (MC) No. 2021-054 dated May 18, 2021 directs LGUs to engage CSOs in the implementation of government programs and participate in the national and local governance processes;

**WHEREAS**, said MC enjoins all LGUs to establish their respective CSO desks and to create and institutionalize the local People's Council in every province, city and municipality;

**WHEREAS**, on September 5, 2022, the Sangguniang Bayan of Moncada granted the accreditation of thirty-two (32) Civil Society Organizations operating in the municipality, approved under SB Resolution No. 21, Series of 2022;

**WHEREAS**, on September 9, 2022, during the CSOs' nomination to Local Special Bodies, the SB Committee on CSOs, DILG Office Moncada, and CSO Desk
