RESOLUTION DESIGNATING THE HONORABLE MAYOR ESTELITA M. AQUINO AS SPECIAL DISBURSING OFFICER (SDO) OF THE CONFIDENTIAL FUND OF THE MUNICIPALITY AMOUNTING TO ONE MILLION PESOS (Php 1,000,000.00) EFFECTIVE JANUARY 1, 2023 TO DECEMBER 31, 2023

WHEREAS, a Local Government Unit whose peace and order is a priority concern is entitled to Confidential and/or Intelligence Fund pursuant to section 4.1.3 of COA-DBM-DILG-GCG-DND Joint Circular No. 2015-01, hereinafter referred to as "Joint Circular", dated January 8, 2015, setting guidelines on the Entitlement, Release, Use, Reporting, and Audit of Confidential (CF) and/or Intelligence Funds;

WHEREAS, the foregoing circular specifically provides that said amount shall be included in the LGU's Peace and Order and Public Safety (POPS) Plan and the same is funded under the annual budget;

WHEREAS, the Local Government Unit of Moncada is entitled to an allocation of CF, after having complied with the prerequisites set forth in the foregoing Joint Circular;

WHEREAS, peace and order is the municipality's utmost concern, hence, a duly allocated appropriation for Confidential Expenses of One Million Pesos (Php
