**RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO AN AGREEMENT WITH THE PHILIPPINE BUSINESS FOR SOCIAL PROGRESS (PBSP) FOR THE ACCESS-TB PROJECT**

**WHEREAS**, presented for consideration by this Body is a proposed Letter of Agreement (LOA) between the Municipal Government of Moncada, Tarlac and Philippine Business for Social Progress (PBSP) for the laboratory services of Moncada LGU Diagnostic Center intended for Tuberculosis screening;

**WHEREAS**, under the LOA, the Municipal Government of Moncada shall charge the Philippine Business for Social Progress (PBSP) for the laboratory services rendered by the Moncada LGU Diagnostic Center for patients who are requested by the Rural Health Units to undergo diagnostic screening for Tuberculosis;

**WHEREAS**, the LGU of Moncada shall charge PBSP based on the costing as agreed and indicated in the foregoing Letter of Agreement;

**WHEREAS**, this August Body, upon the recommendation of the Committee on Health, deems it indispensable for the Local Government Unit to implement measures that will promote the general welfare of its constituents, particularly the provision of quality, inclusive, and cost-effective health services;
