RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY FERDINAND R. MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, FOR THE ALLOCATION OF FUNDS IN THE TOTAL AMOUNT OF FORTY EIGHT MILLION THREE HUNDRED FORTY TWO THOUSAND SIX HUNDRED FOURTEEN PESOS AND 25/100 (P 48,342,614.25) FOR THE PROPOSED CONSTRUCTION OF SLOPE PROTECTION OF BAKET BAKET CREEK (BOTH SIDES) ALONG BARANGAYS TOLEGA SUR TO TOLEGA NORTE, THIS MUNICIPALITY

WHEREAS, the Municipality of Moncada is among the few localities situated in flood-catchment areas in the province, it being traversed by waterways such as rivers and creeks;

WHEREAS, in order to protect the lower catchment areas from landslides, soil erosion and subsequent flooding, one of the identified priority flood control projects is the proposed construction of slope protection of Baket-Baket Creek traversing barangays Tolega Sur – Tolega Norte of this municipality;

WHEREAS, the LGU of Moncada, Tarlac, upon the recommendations of the Municipal Disaster Risk Reduction and Management Office (MDRRMO) and the Municipal Engineering Office (MEO), has incorporated in its Annual Investment Program the above-cited project amounting to forty eight million three hundred forty two thousand six hundred fourteen pesos and 25/100 (P 48,342,614.25);

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations and Committee on Public Works and Infrastructure, hereby earnestly requests His Excellency Ferdinand R. Marcos, Jr., President of the Republic of the Philippines, for the allocation of funds in the total amount of forty eight million three hundred forty two thousand six hundred fourteen pesos and 25/100 (P 48,342,614.25) for the proposed construction of slope protection of Baket-Baket creek (both sides) along barangays Tolega Sur to Tolega Norte, this municipality;

RESOLVED FURTHER, that this Resolution be forwarded to the Office of the President of the Republic of the Philippines for their favorable consideration;
