WHEREAS, acting on the endorsement from the Moncada Municipal Police Station (MPS) apropos to a memorandum from the Provincial Director of Tarlac Police Provincial Office, the 9th Municipal Council passed Resolution no. 58 (s.2019) dated April 29, 2019 denouncing the presence of Communist Terrorist Groups (CTGs) in the municipality;

WHEREAS, there was no report of CTG atrocity within the municipality of Moncada and the people of this town strongly desire that the peaceful situation be maintained;

WHEREAS, nearly four (4) years from the passage of such Resolution from the previous administration, this Sanggunian deems it indispensable to reaffirm the stand of the municipality to deprecate the emergence of such groups that threaten the unflurried conditions of our communities;
