**RESOLUTION INTERPOSING NO OBJECTION TO THE PROPOSED ESTABLISHMENT, OPERATION AND MAINTENANCE OF A COMMERCIAL HOG-RAISING FACILITY (PIGGERY) BY THE BANAONG WEST GOLDEN FARMERS ASSOCIATION, INC. (BAGOFA) UNDER THE DEPARTMENT OF AGRICULTURE'S INTEGRATED NATIONAL SWINE PRODUCTION INITIATIVES FOR RECOVERY AND EXPANSION (INSPIRE) PROGRAM**

**WHEREAS**, the Banaong West Golden Farmers Association, Inc. (BAGOFA) submitted to this August Body their application for a Development Permit last February 16, 2023 relative to the establishment, operation and maintenance of a hog-raising facility (piggery) at Barangay Banaong West under the Department of Agriculture's Integrated National Swine Production Initiatives for Recovery And Expansion (INSPIRE) Program;

**WHEREAS**, the DA's INSPIRE program is an initiative of the national government to provide assistance to African Swine Fever (ASF) – devastated swine industry through the implementation of a calibrated repopulation and enhancement of the local swine industry to recover the sector's capacity to produce sufficient supply of hogs and pork;

**WHEREAS**, after a careful and thorough review of the pertinent requirements submitted by the proponent, the SB finds the same to be compliant with existing laws and pertinent issuances by the government;
