RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE FSK BUILDERS FOR THE ENHANCED IMPLEMENTATION AND SUSTAINABILITY OF THE SOLID WASTE MANAGEMENT PROGRAM IN THE MUNICIPALITY

**WHEREAS**, Local Government Units (LGUs) are mandated by RA 9003 or the Ecological Solid Waste Management Act to ensure the implementation of a sustainable and viable solid waste management program within their territorial jurisdiction;

**WHEREAS**, the LGU of Moncada is presently undertaking its disposal of solid waste by hauling and dumping methods at a designated place under a duly approved disposal agreement;

**WHEREAS**, under the proposed agreement, the LGU of Moncada shall engage the services of FSK Builders to jointly develop and employ a more ecological and environmental-friendly solutions to disposing and recycling solid wastes with the use of the latter's machineries and equipment herein referred to as "Compact Batch Plastic and Tire Waste Pyrolysis;"
