RESOLUTION CONFIRMING AND AFFIRMING THE APPOINTMENT OF MS. RULINA GRACE F. BERMUDEZ AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR) OF MONCADA LOCAL GOVERNMENT UNIT

WHEREAS, Section 443 (d) of Republic Act 7160 or the Local Government Code provides that heads of offices and departments in the LGUs shall be appointed by the municipal mayor, unless otherwise provided, with the concurrence of a majority of all members of the Sanggunian, subject to civil service law, rules and regulation. The Sangguniang Bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

WHEREAS, the Civil Service Commission (CSC) promulgated the revised position titles and qualification standards of Local Planning and Development Coordinators in all levels of LGUs through CSC Resolution No. 1700294 dated February 2, 2017, henceforth, the Sangguniang Bayan of Moncada enacted Municipal Ordinance No. 01, Series of 2023 which provides for the retitling and funding of the position Municipal Government Department Head I (MPDC I) requiring that the MPDC must be a resident of Moncada, a holder of Bachelor's Degree preferably in Urban Planning, Development Studies, Economics, Public Administration or any related course, three (3) years experience in development

planning or in any related field, and must be a licensed Environmental Planner pursuant to RA 10587 and RA 1080;

WHEREAS, the appointment of Ms. Bermudez as Municipal Government Department Head I (Municipal Planning and Development Coordinator I) is in order after having met the minimum requirements provided by law and ordinance;

NOW, THEREFORE, premises considered, and on motion by Coun. Dean Michael V. Duque, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Human Resource Management and Development, hereby confirms and affirms the appointment of Ms. Rulina Grace F. Bermudez as Municipal Government Department Head I (Municipal Planning and Development Coordinator I) of Moncada Local Government Unit;

RESOLVED, FURTHER, that the appointee may enter upon the performance of duties of the Office of the Municipal Planning and Development Coordinator effective on the date of signing of her appointment, furnishing the Civil Service Commission with copies thereof and this confirmation;

RESOLVED, FINALLY, that copies of this Resolution be furnished the Appointee, the Municipal Mayor, the Municipal Human Resource Management Officer and all concerned offices and agencies for their information and appropriate action;
