AGUINO, TO ENTER INTO A TRIPARTITE AGREEMENT WITH THE COMMUNITY SERVICE WITH INTEGRITY - INTELLIGENCE GROUP (CSI-IG) AND PHILIPPINE NATIONAL POLICE (PNP) MONCADA POLICE STATION FOR THE APPREHENSION OF TRAFFIC VIOLATORS IN THE MUNICIPALITY

WHEREAS, entering into a Tripartite Agreement with CSI-IG and PNP Moncada Police Station will provide the Municipal Government of Moncada, Tarlac, with the necessary support and resources to effectively address road safety issues and ensure the worthiness of drivers to use roads and operate motor vehicles;
