**RESOLUTION CONFIRMING AND AFFIRMING THE APPOINTMENT OF MS. DIANA AFANTE AYSON AS MUNICIPAL BUDGET OFFICER OF MONCADA LOCAL GOVERNMENT UNIT**

**WHEREAS**, Section 443 (d) of Republic Act 7160 or the Local Government Code provides that heads of offices and departments in the LGUs shall be appointed by the municipal mayor, unless otherwise provided, with the concurrence of a majority of all members of the Sanggunian, subject to civil service law, rules and regulation. The Sangguniang Bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

**WHEREAS**, Section 475, Article Five of the Local Government Code of 1991 (RA 7160) provides that no person shall be appointed to the position of Municipal Budget Officer unless he/she is a Filipino citizen, a resident of the locality, of good moral character, a graduate of college degree preferably in accounting, economics, public administration or any related course from a recognized college or university, and a second level civil service-eligible or its equivalent; the applicant must also have acquired three (3) experience in government budgeting or in any related field;
