**RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), THROUGH SECRETARY MANUEL M. BONOAN, FOR THE REPAIR AND MAINTENANCE OF A PORTION OF MCARTHUR HIGHWAY / MANILA NORTH ROAD ALONG THE JUNCTION OF BARANGAY RIZAL AND CAMPOSANTO 1 NORTE, THIS MUNICIPALITY**

**WHEREAS**, the residents and concerned citizens of Barangay Rizal and Camposanto 1 Norte, Moncada, Tarlac have been experiencing severe difficulties due to the condition of a portion of McArthur Highway / Manila North Road along the junction of Brgy. Rizal and Camposanto 1 Norte, which has been neglected for a considerable amount of time;

**WHEREAS**, the road is riddled with potholes, cracks, and uneven surfaces that have become a hazard to public safety, posing significant risks to the safety of motorists and pedestrians alike, not to mention the increasing number of road mishaps that occurred over the past years;
