MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, TO DECLARE JUNE 30, 2023 AS A SPECIAL (NON-WORKING DAY) IN THE MUNICIPALITY OF MONCADA, PROVINCE OF TARLAC, IN LIEU OF 01 JULY 2023 WHICH FALLS ON A SATURDAY, TO MARK THE COMMEMORATION OF ITS 148TH FOUNDING ANNIVERSARY

WHEREAS, the Municipal Government of Moncada, Tarlac, along with the Sangguniang Bayan and its constituents, wishes to celebrate this significant milestone and honor the history, progress, and contributions of the municipality and its residents over the past years;

WHEREAS, recognizing the challenge posed by the founding anniversary falling on a Saturday, the 1st of July, 2023, which may hinder the full engagement of our citizens in the planned commemorative activities, the Municipal Government deems it imperative to request the declaration be moved to 30 June 2023, Friday;

WHEREAS, it is indispensable to foster a sense of unity, pride, and community engagement among our residents through their active participation in the momentous events and festivities scheduled to celebrate the 148th founding anniversary of Moncada, Tarlac;

NOW, THEREFORE, on motion by Coun. George Michael P. Aguilar, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Tourism, Culture and the Arts, hereby respectfully requests His Excellency, Ferdinand R. Marcos, Jr., President of the Republic of the Philippines, to declare June 30, 2023 as a Special (Non-Working Day) in the Municipality of Moncada, Province of Tarlac, in lieu of 01 July 2023 which falls on a Saturday, to mark the commemoration of its 148th Founding Anniversary;

RESOLVED, FURTHER, that this Resolution be forwarded to the Office of the President of the Republic of the Philippines, for their favorable consideration;
