WHEREAS, Republic Act 10121, otherwise known as "Philippine Disaster Risk Reduction Management Act of 2010" empowers Local Government Units to provide mitigating and preventive plans and programs, prepare for and earnestly respond to disaster/calamities/crisis/complex emergencies, and attend to relief and rehabilitation work through a Local Disaster Contingency Plan (LDCP) of the Municipal Disaster Risk Reduction and Management Council (MDRRMC) in the Municipality of Moncada;

WHEREAS, the Municipal Risk Reduction and Management Council (MDRRMC) comprised of local officials, functionaries, sectoral representatives and other stakeholders formulated and approved the contingency plan for earthquake under MDRRMC Resolution No. 01, Series of 2023, in accordance with the Prevention/Mitigation, Preparedness, Response and Relief/Rehabilitation pillars of Disaster Risk Reduction and Management;

WHEREAS, the MDRRMC consolidated the foregoing plans, programs and activities into a Local Disaster Contingency Plan for earthquake, consistent with the identified hazards and vulnerabilities in the Municipality;
