RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A NET-METERING AGREEMENT WITH THE TARLAC 1 ELECTRIC COOPERATIVE, INC. (TARELCO I) FOR THE RENEWABLE ENERGY FACILITY INSTALLED IN THE MUNICIPAL GOVERNMENT OF MONCADA

WHEREAS, the Municipal Government of Moncada is committed to promoting the use of renewable energy sources and reducing its carbon footprint;

WHEREAS, the LGU has installed a solar-powered renewable energy facility to provide electricity for its operations;

WHEREAS, as the LGU may generate more electricity than it currently uses, it has expressed interest in entering into a net-metering agreement with Tarlac 1 Electric Cooperative, Inc.;

WHEREAS, a net-metering agreement would allow the LGU to offset from its monthly electric bill the excess electricity it generated, thereby promoting the use of renewable energy and reducing its overall energy costs;

WHEREAS, Tarlac 1 Electric Cooperative, Inc. has expressed its willingness to enter into a net-metering agreement with the LGU, subject to the conditions and standards set by the Philippine Electrical Code, Philippine Distribution Code and other governing laws;
